The following is a summary of the requests for funds by the 76th General Assembly (2009) for **2010** and directions as to where to send those funds:

(1) **GENERAL ASSEMBLY OPERATION FUND:** The Assembly requested the churches to contribute **\$14.00 for each communicant member** to the 2010 General Assembly Operation Fund.

Contributions to the General Assembly Operation Fund should be made payable to the *Orthodox Presbyterian Church*, marked "GA Operation Fund" and sent to 607 N. Easton Rd., Bldg. E, Willow Grove, PA 19090-2539, after January 1, 2010.

(2) **TRAVEL FUND:** The General Assembly requested the churches to contribute **\$10.00 per communicant member** to the 2010 General Assembly Travel Fund. This is the fund that pays for the travel of commissioners to the 2010 General Assembly.

Contributions for Travel Fund should be made payable to the *Orthodox Presbyterian Church*, marked "GA Travel Fund" and sent to 607 N. Easton Rd., Bldg. E, Willow Grove, PA 19090-2539, after January 1, 2010 but before the 2010 General Assembly.

(3) **WORLDWIDE OUTREACH:** The General Assembly approved the following Worldwide Outreach program for 2010.

(4) **DIACONAL MINISTRIES:** The Assembly requested the churches to support the work of the Committee on Diaconal Ministries in 2010 at the suggested rate of **\$25.00 per communicant member** for the General Fund. The Assembly also requested the congregations to give at least half of their contributions by the end of May 2010.
