Here is important information from the 81st (2014) General Assembly of the Orthodox Presbyterian Church that should be of particular interest to all presbyteries and sessions.

ABOUT THE NEXT GENERAL ASSEMBLY

The 82nd General Assembly will be held at Dordt College, Sioux Center, Iowa, June 3-9, 2015, beginning on Wednesday, June 3, 2015, at 7:00 p.m., with a terminus no later than 12:00 p.m. Tuesday, June 9, 2015.

AMENDMENTS TO THE STANDING RULES PROPOSED TO THE NEXT GENERAL ASSEMBLY

Those who are chosen as commissioners to the 82nd General Assembly will need to be aware of seven amendments that have been proposed to the <u>Standing Rules and Instruments</u> by the 81st General Assembly. These will be posted shortly on OPC.ORG at http://www.opc.org/ga.html

THE 2015 EDITION OF THE BOOK OF CHURCH ORDER

A new edition of the Book of Church Order is being readied for printing and distribution at the beginning of 2015. FG XXXII:2 indicates that the BCO is to be updated every five years (in years ending with 5 or 0), so that all the changes that have been approved by the General Assembly and the presbyteries will go into effect with the publication of the new volume. Be sure to look for an announcement early next year of the new BCO's availability for purchase.

ABOUT FINANCIAL REQUESTS FROM GENERAL ASSEMBLY

Here is a summary of the various per communicant requests made or suggested to the churches by the 81st General Assembly for the ministries and operational needs of the Orthodox Presbyterian Church in 2015:
